

FHWA/AASHTO Implementation Assistance Program By State, **Rounds 1-7**

430 Projects Being Implemented Through the **SHRP2** Implementation Assistance Program

The Federal Highway Administration (FHWA), American Association of State Highway and Transportation Officials (AASHTO), and the Transportation Research Board (TRB) are working collaboratively to advance the innovations developed from the second Strategic Highway Research Program (SHRP2). Through the SHRP2 Implementation Assistance Program (IAP), all 50 states, the District of Columbia, and Puerto Rico are implementing SHRP2 Solutions on more than 430 projects. This brochure identifies – by state – these efforts through seven rounds of assistance.

The IAP was designed to assist Federal, state, and local transportation agencies in deploying the SHRP2 products by providing financial and technical assistance, facilitated workshops, training, equipment, and software. Although Round 7 is the final formal IAP offering, some limited opportunities may be available to provide financial and technical assistance using individual SHRP2 products as needs arise and funding permits.

The IAP offers SHRP2 products at three levels of engagement.


